

**ADDENDUM TO THE TERMS AND CONDITIONS FOR
P1 HOT ZONE SERVICES**

This addendum is made to the Terms and Conditions for P1 Hot Zone Services (the “**Services**”) which Packet One Networks (Malaysia) Sdn Bhd (571389-H) (“**Service Provider**”) provides to you (“**Subscriber**”).

(the Service Provider and Subscriber are also hereinafter referred to collectively as “**Parties**” and individually as “**Party**”).

PLEASE READ THIS ADDENDUM TO THE TERMS AND CONDITIONS CAREFULLY BEFORE ACCEPTING THE SERVICE. BY CLICKING THE ‘ACCEPT’ BUTTON AT THE END OF THIS ADDENDUM TO THE TERMS AND CONDITIONS, SUBSCRIBER CONFIRMS ACCEPTANCE OF THIS ADDENDUM TO THE TERMS AND CONDITIONS.

1. Provision of Services

Service Provider agrees to provide and Subscriber agrees to use the Services subject to this Addendum as well as the Terms and Conditions for P1 Hot Zone Services, as amended by Service Provider from time to time (“**Terms**”). For the avoidance of doubt, the provisions of this Addendum shall take precedence over the Terms.

2. Commencement of Service

2.1 This Addendum shall become effective on the date on which Service Provider receives the electronic registration from the Subscriber via the Service Provider’s website and, subject to contrary provisions provided herein, shall continue to be effective until the Promotion Period is over.

2.2 Service Provider reserves the right to decline any application without assigning any reason thereto.

2.3 The Service (as defined below) shall commence on the date on which the Service is ready to be activated by Subscriber (“**Activation Date**”).

3. The Promotion Period

3.1 The Service shall be free only from 27.6.2007 to 31.12.2007 (hereinafter called the “**Promotion Period**”).

3.2 The Subscriber will be notified, via e-mail sent to his/her last known e-mail address and/or a short messaging service (SMS) sent to his/her last known handphone number, on or before 1.12.2007, about the expiry of the Promotion Period. The e-mail and/or SMS will also inform the Subscriber about subscribing to the Service as a paying subscriber via the Service Provider’s website, which will also contain the relevant pricing plan.

4. Termination

4.1 Without prejudice to any other rights or remedies of Service Provider under this Addendum and the Terms & Conditions for P1 Hot Zone Service, Service Provider shall have the option to terminate the Services to the Subscriber on or after 1.1.2008 if the Subscriber has not registered as a paying subscriber by 31.12.2007, whereupon the Subscriber’s user ID will be deleted and will then be made available to P1 Hot Zone’s paying subscribers.

5. Other services

- 5.1 For the avoidance of doubt, any value added services offered before 31.12.2007 will not be free to the Subscriber. These services will have their own terms and conditions.
